This letter is in regard to your event, _____,

That will be held the date(s) of _____. This event will be insured by our insurance carrier and sanctioned by the Western States Corvette Council.

In order to protect your sanction, you must comply with the following requirements. Failure to do so will result in loss of your sanctioning and forfeiture of your performance bond (Insurance Certificate).

1. For Events requested with Type I or Type II WSCC Sanctioning:
 - a. Flyers advertising your event MUST be mailed to all WSCC clubs within the region 45 DAYS prior to the event. This can be accomplished by sending your event flyer via email to reps@wscw.ws or by regular USPS. Please post your flyer to the WSCC website under Events – Flyers (See website for instructions). Your flyer must also include the current WSCC logo. Refer to the Competition Code, Guidelines for Activities for details.
 - b. Current WSCC Judging Sheets MUST be used for all Type I events.
 - c. For Autocross or Slalom a course map must be provided in accordance with Part III, Article II, Section I-G of the Competition Code.
 - d. Please refer to the current Competition Code for all other requirements for your type of event.

2. For Events requested with Type III, Type IV or Type V WSCC Sanctioning:
 - a. If Sanctioning an Autocross or Slalom, you must submit the fee for Insurance Coverage of \$_____ per event made payable to WSCC, within 10 days from receipt of this letter.
 - b. If Sanctioning a Car Show or Park and Show, you must submit the fee for Insurance Coverage of \$_____ per event made payable to WSCC, within 10 days from receipt of this letter.
 - c. If an “Additional Insured” Certificate of Liability is required for a Type III, IV or V social event, there is currently No Charge to the submitting Club.
 - d. Please refer to the current Competition Code for all other requirements for your type of event.

If your event is cancelled, please provide written notice 30 days in advance to all WSCC Clubs, WSCC Events Director and Board of Directors.

The WSCC Events Director will forward your event Certificate of Liability Insurance via mail (electronic or USPS) when it is obtained from our carrier.

FAILURE TO MEET THE ABOVE REQUIREMENTS WILL RESULT IN CANCELLATION OF YOUR EVENT SANCTIONING.
